- e) Restructuring BOD positions: Chris and Ron are working on BOD structure. Will have report at November BOD Meeting.
- f) Issue on certification for KEC: Resolved.
- g) Associate members have guidelines and obligations for membership: Chris and Ron are working on the Associate Member Guidelines. Should have ready by December BOD meeting.
- h) Coding logos for directory: Will have to hire someone to code listings for members. Will have done by November BOD Meeting.
- i) Hire professional Executive Director: Search will begin in January. Looking for someone with an entrepreneur's mind. Will need to possibly raise dues to cover costs of salary. May ask the membership about raising their renewals and explaining that it is necessary to hire an ED.
